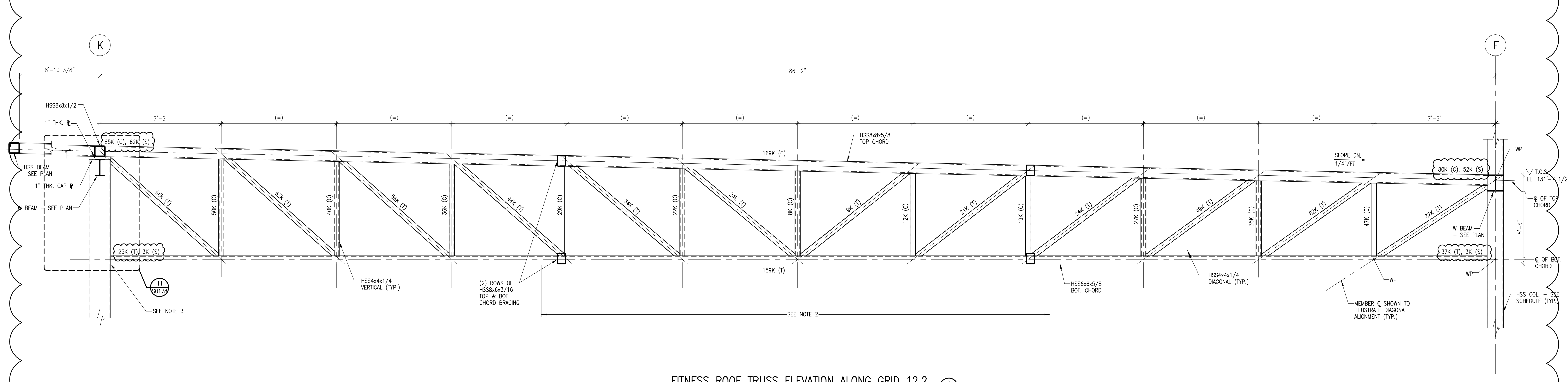

SCALE: 3/8"=1'-0"

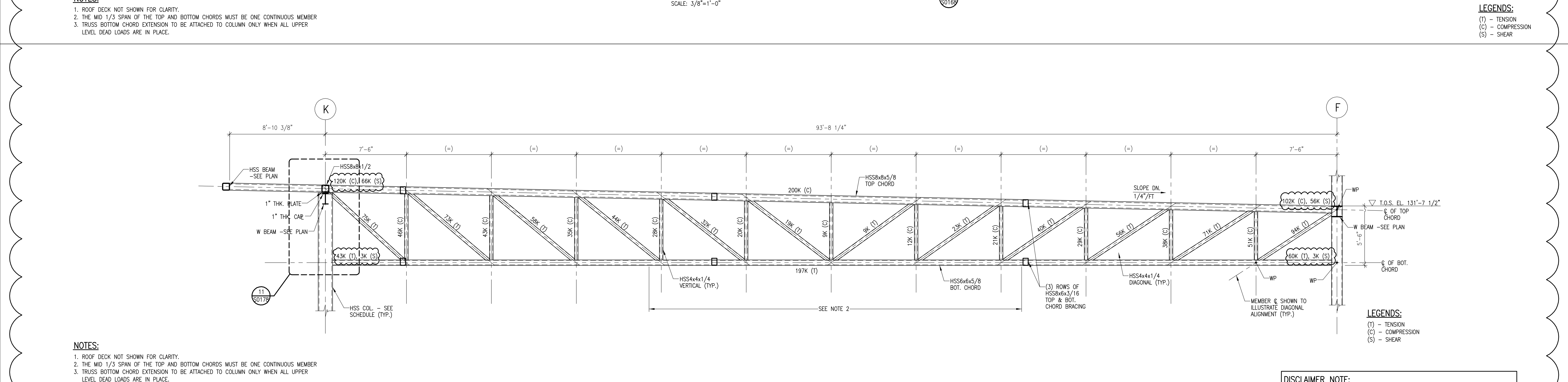

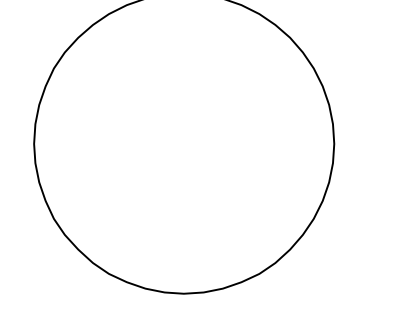

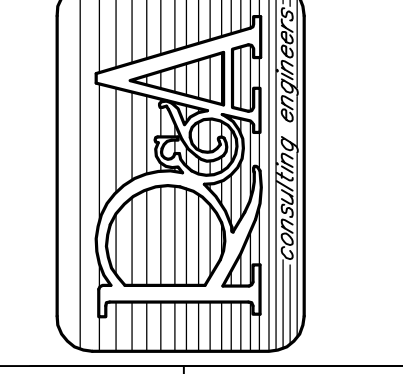
FITNESS ROOF TRUSS ELEVATION ALONG GRID 13.2
