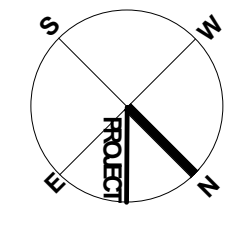

GENERAL NOTES

1. SEE A-1.0 FOR ACCESSORY SCHEDULE.
2. CLEAN, REPAIR, PREPARE, AND PAINT ALL GYPSUM BOARD SOFFIT AND CEILING SURFACES.
3. CEILING AND SOFFIT SURFACES MAY BE PAINTED A DIFFERENT COLOR THAN ADJACENT WALL COLOR.
4. VERIFY EXISTING SUBSTRATES ARE DRY AND FREE FROM LEAKS BEFORE REPAIRING GYPSUM BOARD SURFACES OR INSTALLING NEW CEILING FINISHES. NOTIFY ARCHITECT IF LEAKS, OR WET SURFACES ARE DISCOVERED.
5. ALL WALLS ARE FULL HEIGHT EXCEPT AS NOTED OTHERWISE.
6. SEE MECHANICAL, ELECTRICAL AND PLUMBING SHEETS FOR ALL MEP ITEMS. ALL MEP ITEMS SHOWN ON THE REFLECTED CEILING PLANS ARE FOR REFERENCE ONLY AND SHOULD NOT BE USED FOR CONSTRUCTION.
